



PARTICIPANT DEPOSIT AGREEMENT

This "Participant Deposit Agreement" constitutes a binding agreement between the "Player", _____, _____, his/her Parent(s) or Guardian(s) _____, and Manchester Regional Youth Hockey Association, hereinafter MRYHA.

Deposit: Team deposits are **NON-REFUNDABLE/NON-TRANSFERABLE**. This means, for example, that a deposit will not be transferred between siblings. ____ [initial]

Tuition: MRYHA does not allow a Player to participate in its program or skate with the team if the Player's tuition obligation is not met by the August 1, 2010 deadline, unless the Registrar and/or Division VP otherwise previously agreed in writing. You will be charged a \$40.00 fee for any returned check and shall fund the returned check within 7 business days of receiving notice from MRYHA. ____ [initial]

Responsibility: The Player and his/her Parents/ Guardians are fully responsible for the Player's financial obligations. MRYHA does not participate in payment disputes between family members. ____ [initial]

Withdrawal Policy: A Player's withdrawal from the program **MUST** be in writing **to the Registrar and/or Division VP**. All withdrawals shall be subject to the following penalties:

- Prior to April 1, 2010 = Full deposit forfeited. ____ [initial]
- After April 1, 2010 but before May 1, 2010 = Full deposit plus ½ (one-half) of the total tuition owed shall be due and payable immediately. ____ [initial]
- After May 1, 2010 = the entire tuition shall be due and payable immediately. ____ [initial]

Release: MRYHA shall not grant a "Player Release" until the Player's entire financial obligations are satisfied. League equipment constitutes financial obligations under USA Hockey regulations. The Player must return his or her jersey or MRYHA will charge a \$100 per jersey replacement cost. USA Hockey and NHAHA may be notified if a Player owes a financial obligation to MRYHA. ____ [initial]

Injuries: Prorated refunds may be granted to a Player that suffers a "season ending" injury while playing on a MRYHA USA Hockey Roster team during the regular season. MRYHA does not prorate or refund any tuition if a player misses time due to injuries not associated with this USA Hockey Roster team. ____ [initial]

Mouth Guard Policy: MRYHA requires and enforces mouth guard use for Peewees, Bantams and Midgets for all games, scrimmages, and practices, as required by USA Hockey.

Neck Guard Policy: MRYHA requires and enforces a neck guard use for all games, scrimmages and practices, for players in Intro Mites through Bantams.

Discipline: No refunds or credits shall be provided to any player suspended or removed from their team due to discipline by MRYHA's Discipline Committee, NHAHA, or USA Hockey.

USA Hockey: The Player is responsible for registering with USA Hockey prior to the first practice pursuant to USA Hockey Rules and Regulations. Register at www.USAhockey.com.
